DBA requirements are based on enrollment status:

Student Type	DBA Requirement
Full-time SJVS students	Must attend a zoom meeting with camera on to complete Module 5 DBA. Students will book their DBA time using the booking site. Be prepared for your DBA to take about 10 minutes. Module 4 and 6 DBAs will be exempt if the student is in good academic standing.
Flex (Home Ed, Part-time brick and mortar students)	Must complete all DBAs. DBAs will be via phone call. Book your DBA using the booking site.
